Aim :

School Rules: Observance of the following is compulsory for all students and deviations will lead to disciplinary action:

General:

- Attendance in the morning assembly is compulsory. Disciplinary action will be taken against the defaulters and late comers. Students arriving late will not be allowed to enter school

premises without a plausible explanation. Students found to have come late for more than one day in a term/semester will not be allowed to attend classes on second such occurrence.

- Silence must be observed in the corridors and the stairways during school hours and the same should be maintained while proceeding to the labs, library or any other activity classes.
- For birthdays, a student can wear civil dress. Students are not allowed to celebrate their birthday or any other occasion in school by distributing sweets or chocolates. Book can be donated to the school library.
- Criticism of teachers should be avoided in the presence of the student. Any change in the residential address or telephone numbers should be immediately notified to the school authority.
- Students are not allowed to wear any ornaments or bring any valuable article such as FM Radios, I-pods, Calculators, Mobile/Cellular phones, CD or other storage devices like floppies; pen drives or not relevant to academic pursuits, to the school. Bringing money to the school is not allowed. Bringing, cameras, expensive pens, cosmetic, combs, perfumes, deodorants etc, to school is also strictly forbidden. Students are not allowed to bring any weapons or sharp instruments. Violation may result in suspension and /or levying of heavy fine. Item once confiscated will not be returned under any circumstances. Parent will not be entertained on these issues
- No student has the permission to commute to school on self-driven two/four wheelers.
- It is expected from each and every student that they maintain a very cordial relation with the teaching/non-teaching/housekeeping/transport staff of the school. In no case should they get into arguments with the staff. In case of complaints they must approach the Principal.
- The school reserves the right to terminate the continuance of students with unsatisfactory progress in studies or whose conduct is a bad example for others.

Language:

- All must speak in English in the school. Bullying and the use of foul language are punishable offences, whether in or out of school. Students found using the same will be expelled.
- The school has Zero tolerance for incident, vulgar, foul, abusive and uncouth language (spoken and written). Pupil must ensure that the manner of speaking is always pleasant, controlled and grammatically correct. The common language for everybody at school, is compulsorily standard world English, except in a class where a language other than English is being taught or in a related event.

Dress Code:

- Uniform is compulsory during school hours and all school functions including all such instances where students are representing the school outside. The turnout is checked during the morning assembly and defaulters are liable to be punished/fined.
- Students will wear sports uniform with sports shoes and socks on Wednesday & Saturday.
- In the Pre-Primary students will wear activity dress on Wednesday.

School Property:

- Care must be taken of all school property. Students must not write on the walls, or carve on wood work/furniture.
- Damaging or disfiguring any school property may result in suspension/expulsion from school in addition to levy of heavy fine.
- All breakage or damage to school property, even if accidental, must be immediately reported to the Class Teacher and A.O.
- The cost of the repairs to the damage to school property will be charged to the pupil concerned. A fine of a minimum of Rs. 500/- will be applicable. With reference to this a mail will be sent to the parents.

Disciplinary Measures:

The following disciplinary measures may be adopted by the school in dealing with students behaving in an unruly manner.

- Oral warning and counseling.
- Written warning.
- Detention during the break, or for the whole day.
- Suspension (ranging from 7 days to 30 days)
- Rustication.
- Withdrawal of transport facility for misbehaviour in the school bus. In such cases, parents will be responsible for their ward's commute to school.
- Misbehaving in class with peers/teachers may result in suspension from school for a month or even expulsion without notice.

Absence From School:

- No student who has been absent on the previous day, will be allowed to attend class unless her/his parent has entered an explanation stating the reasons for the absence, in the 'Record of Non-Attendance' section of the diary, for each day the student has been absent from school. It is the responsibility of absentee students to ensure that their parents have entered the relevant information and signed the diary. In case a child reports to school without an explanation in the diary, the parents will be summoned to school and child will be sent back home.
- In case of absence of more than two days on medical grounds, medical certificate and prescription should be attached along with the application.
- A student, returning to school after suffering infectious or contagious disease, should produce a doctor's fitness certificate permitting her/him to attend school. Student's suffering from the following disease must observe the prescribed period of quarantine before returning to school:
- Students, who require medical attention during school hours, may be sent to the School Infirmary by the teacher concerned, who will enter the nature of the complaint and sign the 'School Infirmary Record' section of the diary.
- Students should not, except in emergency situations, visit the school infirmary, unless entry has been made in the diary, by the teacher.
- Parents will be promptly informed in the event of serious illness or emergencies and may be requested to come to school to take their ward home, if necessary.
- Repeated absence without notice or unexplainable absence without written application for more than 1 month renders the student liable to have her/his name struck off the rolls. Re-admission may only be granted after payment of a re-admission fee.
- All students are expected to attend school on the re-opening day immediately following the vacations. Absence on the day of re-opening of the school will attract strict disciplinary action/fine.
- It is compulsory for students to achieve 90% attendance. This stipulation can only be relaxed on genuine medical grounds, at the sole discretion of the principal.
- Second Wednesday of every month will be a bag free day.

School Transport Rules:

- All students using the school bus / Van are expected to be on the left side (entry side) of the bus at least five minutes before the arrival of the bus .
- Bus/van service will be provided to students up to a convenient point near the house.
- Any damage or misbehavior in the bus/van, will result in the stopping of the bus/van services of the particular child.
- The drivers shall not wait for any child. The child should be ready at the pick-up point well in advance of the pick-up time.
- If no one is present to take the child at the drop point, at the given time, then the child will be brought back to the school and the parents will have to pick the child from the school.
- Pick-up and drop points will be the same.
- Any change in the address during the academic year does not guarantee continuation of the bus service. A student can be accommodated only after checking the availability in the bus.

- Under no circumstances should students touch the instrument panel/first aid box/fire extinguisher of the bus.
- Students are allowed to use only their allotted bus stop. There is no provision for temporary change in bus or bus stops.
- Students must make sure that the aisle of the bus is clear, and that school bags and other belongings are placed properly.
- Students must keep all parts of their body, inside the bus, at all times. They should not put their hands out, even for waving.
- No object should be thrown inside or outside the bus/van.
- The consumption of edibles and drinks is not permitted, in the bus/van.
- Unruly behaviour like shrieking and shouting, is strictly prohibited.
- The driver's attention must not be distracted for any reason.
- The drivers are authorized to stop buses at designated stops only, unless otherwise directed by the bus attendants after consultation with the Transport in-charge.
- The list of stops is prepared, keeping in view, the convenience and safety of all bus/van commuters and is subject to change.
- Parents should, for the safety of their children, ensure that their wards are always escorted to and from the stops.
- Parents are not allowed to enter the bus under any circumstances nor is it expected that they should get into an argument with the driver/attendant. Transport facility of the child may be suspended or even cancelled for any such confrontation reported. For any issue, parents must approach the A.O/Principal and lodge the complaint.
- Parents should meet concerned teachers on every fourth Saturday i.e. parent-child-teacher meet (PCTM) or specific Open Days or as and when requested by the school.
